

## PRIVACY POLICY

Your privacy, and the privacy of all our visitors, is important to HySpeed Computing. We've therefore developed a Privacy Policy that describes how we collect, use, disclose, transfer, and store your information. #### **Conditions of Use**

To provide the best experience possible for all visitors to our website and users of our services, HySpeed Computing has also established Terms and Conditions. #### Consent

By using the HySpeed Computing website or our services, you consent to both our Privacy Policy, as described herein, and our Terms and Conditions. If you do not consent, or disagree with our policies, then your best recourse is to discontinue using our website and services.

#### **General Overview**

HySpeed Computing collects non-personal information from our website visitors, and personal information from members when they register with our community. Information is only collected and used as necessary for our legitimate business purposes. Information may be used to personalize your experience, administer the website, understand and analyze trends, and improve user experience. Note that the information we process and store is kept in accordance with the applicable United States legal requirements. HySpeed Computing is committed to maintaining the integrity and privacy of your information, and has appropriate security safeguards in place to protect your information.

## **Personal Information**

When you register to become a member of the HySpeed Computing community, we may collect certain personal information, including, but not limited to, your name, email, affiliation, and general interests for joining the community. Additionally, if you download data sets or other files from our website, we may collect a record of the download. The email address and other personal information you provide, including your history of data set downloads, may be used to send you information, respond to inquiries, and/or convey other requests or questions.

### Non-Personal Information

As has become standard operating procedure for most websites, we collect certain non-personal information about visits to our website. Examples of information collected may include, but are not limited to, internet protocol (IP) address, internet service provider (ISP), browser type, language, date/time stamp, length of visit, and referring/exit pages. Our website may also employ third party services, such as Google Analytics and Yahoo! Web Analytics, which have their own separate and independent policies. By using the HySpeed

Computing website or our services, you are also consenting to the use of these third party services. We may collect, use, transfer, and disclose non-personal information for any purpose. For example, non-personal information may be used for our business purposes, including, but not limited to, analyzing trends, gathering broad demographic information, administering the website, and improving the design and content of the website.

# **Internet Technologies**

The HySpeed Computing website and our services may use cookies, log files, and other internet technologies to better understand visitor behavior, enable certain technical operations, improve user experience, save preferences for future visits, and collect nonpersonal information. If you configure your browser to opt-out of cookies, or other applicable internet technologies, note that you may not be able to use the full functionality of our website and services.

### **Third Party Disclosure**

HySpeed Computing does not sell, share, distribute, or otherwise transfer to outside parties your personally identifiable information, unless otherwise outlined herein. For example, we may employ trusted third parties who assist us in operating our website, conducting our business, or servicing you, so long as those parties agree to keep this information confidential and not use it for other purposes. We may also release your information when we believe release is appropriate or necessary to comply with the law, legal process, litigation, and/or requests from public and government authorities within or outside your country of residence, to enforce our site policies, or to protect ours or others rights, property, or safety.

## **International Transfer**

Your information may be transferred to and maintained on computers and servers located outside of your state, province, country, or other governmental jurisdiction where the privacy laws may be different than your own jurisdiction. Your consent and submission of such information represents your agreement to that transfer. Additionally, if you are located outside the United States and choose to provide information to us, your consent acknowledges that HySpeed Computing processes your information in the United States.

### **Security**

HySpeed Computing utilizes a variety of security measures to safeguard your personal information against loss, misuse, and theft, as well as protect against unauthorized access, disclosure, alteration, or destruction. Information we collect is stored in password-protected servers, and we take reasonable efforts to maintain security; however, no security system is impenetrable and therefore we make no guarantees regarding your personal information. If you have registered with HySpeed Computing to become a member of our innovation community, it is important for you to protect against unauthorized access to your password and/or computer. Should you feel your password has been compromised, instructions are provided on the website for you to change your password.



#### Children

HySpeed Computing does not knowingly collect any personal information from children under the age of thirteen, and if it is later learned that any personally identifiable information has been inadvertently collected from a child under the age of thirteen, we will promptly take steps to delete such information.
